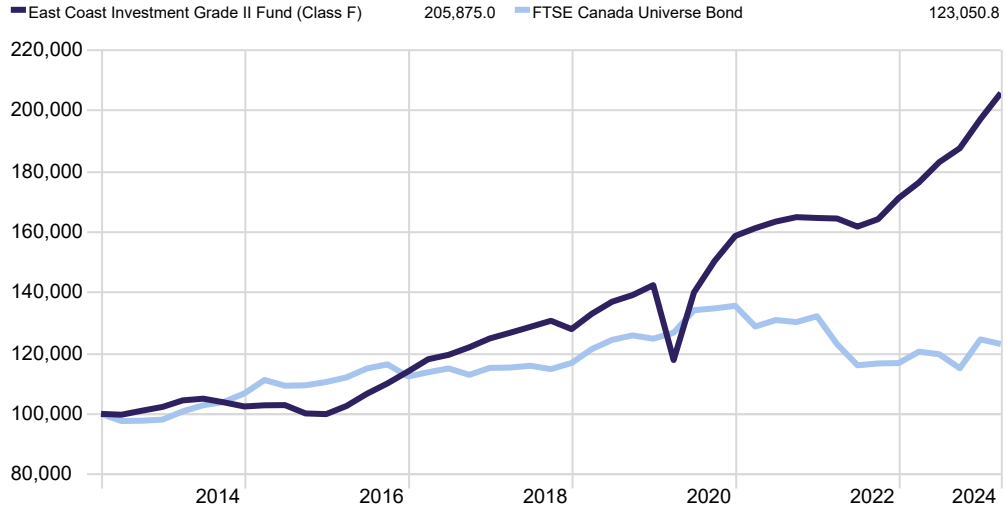
## Correlations: Adding Fund to Portfolio Improves Diversification
