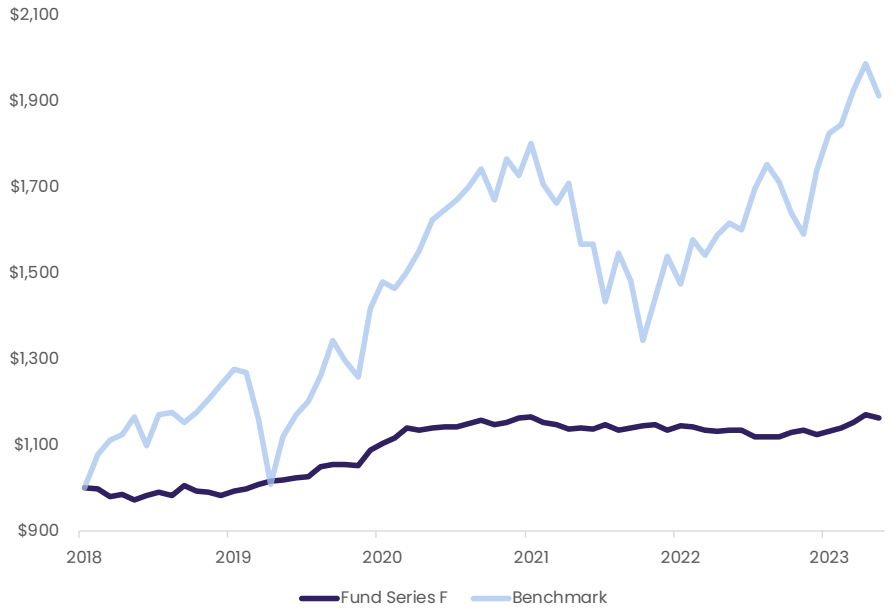

Time Period: 2019-01-01 to 2024-04-30



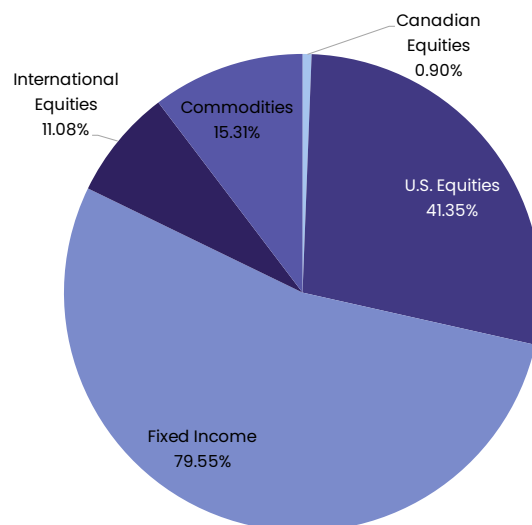
